## **Executive Director Update:**

-Director Doyle gave a power point presentation to the Board via screen share "HIDA 2020 Year End" – attached. Highlights below:

- ✓ Deficit (\$35,000), \$47,000 due in project receivables not yet closed.
- ✓ Moved up in Business First ranking from 16<sup>th</sup> to 8<sup>th</sup> positive indicator of agency performance.
- ✓ Project extension fee waivers saved local businesses \$79,500
- ✓ Southtowns Chamber highlighted the HIDA sponsorship initiative supporting local businesses
- ✓ Town Retail Committee completed a 50 page report highlighting the strengths and weaknesses of the town economy, implemented the 485 (b). The 485 (b) is not an IDA project, it is handled by the town assessor. It will be a good tool to use to track progress and growth in the town.
- ✓ 3 projects are in the pre-permit process for the LECC Parcel
- ✓ Town Comprehensive Plan completed, the updated plan can open the town up for more funding opportunities.
- ✓ HIDA Retreat is scheduled for February.
- ✓ Pitch Hamburg is moving forward, currently in the fundraising phase.
- ✓ January 2021, Doyle will begin training to become a Certified Economic Development Consultant.

### **New Business:**

Three companies E-One, The Oaks at South Park and Upstate Steel are all looking for sales tax extensions. Due to the pandemic and supply chain issues they simply cannot make purchases in the current amount of time granted. The only thing changing is the period of time. They are requesting either a 3 or 6 month extension.

RESOLUTION OF THE TOWN OF HAMBURG INDUSTRIAL DEVELOPMENT AGENCY EXTENDING THE INDUCEMENT PERIODAND THE SALES TAX PERIOD FOR BILLY-LEE, LLC PROJECT , UNTIL JUNE 17, 2021

WHEREAS, the Town of Hamburg Industrial Development Agency (the "Agency") by resolution adopted on December 27, 2019 induced Billy-Lee, LLC (the "Lessee") for assistance by the Agency including mortgage tax abatement, sales tax exemption on any materials and/or equipment purchased for incorporation into Project and real property tax abatement in accordance with existing Agency Uniform Tax Exemption Policy and Guidelines, as amended, with respect to a lease with mortgage or lease only transaction for the construction of an approximately 10,000 square foot addition to an existing building located at 4760 Camp Road, Hamburg, New York, by the Lessee, as Agent for the Agency, for lease to the Agency and subsequent Leaseback to the Lessee. The Lessee will be the sole occupant, all for the provision of a fire truck manufacturing Facility (the "Project"); and

WHEREAS, due to COVID - 19 pandemic and the mandated construction shutdown and the supply-chain delays as a result of border closings and supply demands, the Lessee has been unable to complete the Project within the time frame originally anticipated and has requested that the time period for completion be extended from December 17, 2020 to June 18, 2021; and

WHEREAS, The Town of Hamburg Industrial Development Agency approved a temporary policy to waive extension fees for project extensions for COVID-19 Pandemic related delays on May 26, 2020 to lessen the economic burden of induced project delays related to the COVID-19 Pandemic.

NOW, THEREFORE, BE IT RESOLVED BY THE AGENCY AS FOLLOWS:

RESOLUTION OF THE TOWN OF HAMBURG INDUSTRIAL DEVELOPMENT AGENCY EXTENDING THE INDUCEMENT PERIOD AND THE SALES TAX PERIOD FOR THE OAKS AT SOUTH PARK, LLC, UNTIL MARCH 26, 2021

WHEREAS, the Town of Hamburg Industrial Development Agency (the "Agency") by resolution adopted on June 25, 2019 induced The Oaks at South Park, LLC (the "Lessee") with respect to the acquisition and equipping by the Agency with the proceeds of a lease with mortgage for the acquisition by the Lessee of an approximately 27 acre parcel of land located at 5138 South Park Avenue in the Town of Hamburg, the construction by the Lessee, as agent for the Agency (i) the adaptive re-use of a former school building and re-development the parcel of land for construction of 19 two-story buildings totaling 152 housing units and (ii) installation of baseball and softball fields and other amenities and the acquisition and installation of machinery, equipment, furnishings and fixtures by the Lessee, as agent for the Agency, all for a residential housing complex with additional services (the "Project"). The project will be leased by the Lessee to the Agency for sublease back to the Lessee for sub-sublease to residential tenants which will be the occupants of the project.

WHEREAS, due to COVID - 19 pandemic and the mandated construction shutdown and the supply-chain delays as a result of border closings and supply demands, the Lessee has been unable to complete the Project within the time frame originally anticipated and has requested that the time period for completion be extended from June 26, 2020 to March 26, 2021; and

WHEREAS, The Town of Hamburg Industrial Development Agency approved a temporary policy to waive extension fees for project extensions for COVID-19 Pandemic related delays on May 26, 2020 to lessen the economic burden of induced project delays related to the COVID-19 Pandemic.

RESOLUTION OF THE TOWN OF HAMBURG INDUSTRIAL DEVELOPMENT AGENCY EXTENDING THE INDUCEMENT PERIOD AND THE SALES TAX PERIOD FOR 2019 BETLEM ASSOCIATES, LLC PROJECT, UNTIL APRIL 18, 2021

WHEREAS, the Town of Hamburg Industrial Development Agency (the "Agency") by resolution adopted on August 27, 2019 induced Betlam Associates, LLC (the "Lessee") with respect to the acquisition and equipping by the Agency through a lease with mortgage or lease only transaction of a commercial facility consisting of the acquisition of an parcel of land consisting of 3.5+/- acres located 250 Lake Avenue (a/k/a 0 Lake Avenue), Hamburg, New York and the renovation of an approximately 90,000 square foot building therein, by the Lessee, as Agent for the Agency, for lease by the Lessee to the Agency for sublease to the Lessee for sub-sublease to Upstate Steel, Inc., (the "Sublessee") who will be the sole occupant of the facility, all for the provision of a manufacturing and distribution Facility (the "Project"); and

WHEREAS, due to COVID - 19 pandemic and the mandated construction shutdown and the supply-chain delays as a result of border closings and supply demands, the Lessee has been unable to complete the Project within the time frame originally anticipated and has requested that the time period for completion be extended from October 18, 2020 to April 18, 2021; and

WHEREAS, The Town of Hamburg Industrial Development Agency approved a temporary policy to waive extension fees for project extensions for COVID-19 Pandemic related delays on May 26, 2020 to lessen the economic burden of induced project delays related to the COVID-19 Pandemic.

The topic will be "The New Now – the Power of Social Media during a Pandemic. It will be promoted with 2 ads in the Hamburg Sun and on Social Media thru the Southtowns Chamber.

# **New Business**

-Race Storage Sheds, acquisition and renovation of print production facility for fabrication of residential outbuildings. , Doyle went over the project file and application with the board.

- Existing business, have not previously applied for benefits thru the IDA
- Benefits are less than \$100,000 no public hearing
- 7 year PILOT, estimated company incentives (Property Tax \$77,737, Mortgage Tax 4,000 and Sales Tax \$1,750).
- 2 new full time jobs created (\$35,000 to \$45,000)
- Start date January 2021

Wence asked if salaries figures listed above included benefits, they do not. \$17 to \$21.50 is a decent wage. Janet stated the property previously a volunteer fire hall has never been on the tax roll. Any gain on the property is a net gain.
