Description is critical in determining eligibility I am the owner of three manufacturing companies located in the Village of Hamburg: KH Industries, Inc. (KH) and Staub Precision Machine Inc. (SPM), and Alert Reels Manufacturing. KH Industries, Inc., incorporated in 1960, is a manufacturer of temporary lighting and power products. I have managed KH for over 25 Manufacturing. KH Industries, Inc., incorporated in 1960, is a manufacturer of temporary lighting and power products. I have managed KH for over 25 years and steadily increased our sales and workforce. KH currently employs 43 full-time and 6 part-time employees. With the help of the Hamburg IDA, we expanded in 2010, relocating our facilities from Angola, NY to a 90, 000 square foot vacant envelope factory at 160 Elmview Ave in Hamburg. We have made significant investments to remodel this building, spending more than \$2.6M so far on repairs and upgrades. This building is held by Grimsview Properties, an LLC that I also own. In January 2018, I purchased the assets of Staub Machine Inc., a 40 year old machine shop and renamed it Staub Precision Machine Inc. Staub Machine employed 21 full-time and 1 part time employee at the time of purchase. Today SPM employs 28 full-time and 4 part time employees. SPM is a now a lights-out machine shop that produces high-precision machined components. The company supplies components to a very diverse set of customers that produce medical equipment as well as guitars, telecommunications, defense and aerospace products. We currently have three customers that nonduce oxygen therapy equipment. We are their sole-source supplier for parts that are used in home oxygen concentrators. a very diverse set of customers that produce medical equipment as well as guitars, telecommunications, defense and aerospace products. We are their sole-source supplier for parts that are used in home oxygen concentrators, liquid oxygen tanks and ventilators for hospitals. During the COVID-19 pandemic, demand for these products from our customers has risen dramatically. In order to meet this demand, we have recommissioned machines from sorage, purchased several new CNC machines, and implemented additional automation to significantly increase our production capabilities. We have spent over \$2.5M on additional equipment last year alone. SPM operates within three separate facilities in Hamburg that are leased from the former owner. Two of the SPM manufacturing facilities are located directly across the street only one mile apart, this physical distance results in much inefficiency. The Lake St. plant is located in the back of a retail plaza. Our space in the building is completely utilized, with no room for additional equipment or staff. Two of the SPM manufacturing facilities are located on Grimsby drive. The third and largest SPM facility is located at 206 Lake St., about 1 mile away from the 2/4 Grimsby Dr. buildings. Although the facilities are only one mile apart, this physical distance results in a number of inefficiencies. The Lake St. plant is located in the back of a retail plaza. Our space in the building is completely utilized, with no room for additional equipment or staff. The building has three different electrical services (all approaching max. capacity) Expansion here would require purchasing the property, evicting the long term tenants, rehabbing the building and making significant upgrade to the sites electrical service. This would be very expensive option that would still leave businesses physically separated. To maximize our production capabilities and alleviate our space constraints we would prefer to build a new 40,000 square foot manufacturing facility for Staub Precision Machining. The proposed building would be on the vacant land at the end of Grimsby Drive. The building would be held by Staub Three, an LLC that I also own. Staub Precision Machining would then consolidate our high volume manufacturing equipment to this building. This would allow us to scale our operations significantly to meet current and future customer demands. This is a great opportunity to secure and bring addition jobs to our local community. With assistance from HIDA, we are looking to freeze the assessed value of the property for 7 years, and also have the mortgage recording tax benefits to Staub Three, LLC and sales tax exemption benefits for Staub Precision Mach

The Agencies assistance is critical to help us through this expansion project. Post pandemic we are in a very good position to continue our footprint within the industry. In order to do so we need a proper building that is tailored to our operational and manufacturing needs. Last year we purchased the Evans Bank building for our engineering and administration with HIDA's help. Now we need to take the next steps to become a serious competitor within the manufacturing landscape. To gain manufacturing efficiencies and minimize potential quality issues from material movements between three locations we need to consolidate our high volume operations in one modern facility. We have proven our commitment to the community. In 2018 we considered last minute because we feel like we belong in Hamburg, it would have been an ideal building for Staub Precision and very affordable. We walked away at the purchase of Staub in 2018. We have \$3 million internal investment with more planned. Gaining the Agencies assistance is the only way we will be able to move the financial pieces required to make the investments we need in highly skilled labor, advanced equipment, and automation to help us get to the
