- A letter from the Town to NYS Department of Transportation requesting a Break-In-Access onto New York State Route 5 to service the Lake Erie Commerce Center was reviewed. This is the first step in the process to obtain the Break-In-Access. The sale of 50 acres of land in the industrial park is contingent on receiving DOT approval.
- -A proposal from Wendel to provide professional services for the NYSDOT Break-In-Access request for the Lake Erie Commerce Center was discussed. The scope of services to be provided include:
 - 1. Assistance during conceptual review
 - 2. Concept Access Plan Development
 - 3. Traffic Impact Study
 - 4. Prepare a Freeway Access Modification Report
 - 5. Provide assistance during NYSDOT review

The total fee for the contract with Wendel would not exceed \$52,700.00. This total includes \$13,900.00 for a traffic study, the funding of a \$10,000 portion of which was previously approved by the agency.

- -Mike Sendor, Kevin Kreutzer, Bob Hutchinson and Executive Director Bartlett have met with three website companies. After reviewing the proposals, it was recommended that I Evolve Technology Services be hired to develop websites for both the HIDA and HNYLDC. Kevin Kreutzer reviewed the reasons for choosing I Evolve and Bob Hutchinson answered several technical questions raised by the board.
- **Motion** to authorize Executive Director Bartlett to sign a contract with I Evolve Technology Services to design websites for the Town of Hamburg Industrial Development Agency and Hamburg new York Land Development Corporation including a Responsive Build option for a cost not to exceed \$7,425.00 and hosting fees not to exceed \$900.00 annually for both sites.

-The Land Development Corporation has received a bill from the Town for \$15,000 for interest for 2013 on the loan the LDC received from the Town for the purchase of the Bayview/Route 5 property. The LDC currently has \$7,301.74 of assets in the form of a checking and savings accounts. The LDC has received \$95,000 from the HIDA in two separate loans (\$75,000 & \$20,000). A Discussion took place on the amount of the loan and it was agreed to lend the HDC \$25,000 to cover the interest payment to the Town and leave the LDC with some operating funds.

- -A discussion took place as to whether the LDC should be charged interest by the HIDA for the three loans they have received. Bond Council Neill felt that interest should be charged once the LDC sold off some of the land and had funds on hand. He suggested a rate of 2% per annum commencing on January 1, 2016. The Board agreed with the Bond Council's recommendation and the resolution and note will reflect the recommendations.
- Due to delays in arranging financing and an extremely cold winter, K&H Industries has not been able to start their remodeling/repair project at the former American Envelope building on Grimsby Drive in the Town. Their sales tax exemption expires on 3-15-14, and they are requesting a one-year extension.

After negotiations with the Town , work is moving forward, but an extension is needed to complete the last two buildings in Phase I. It is the opinion of Bond Council Nathan Neill that the request for an extension is reasonable. It is also Mr. Neill's opinion that an extension to August 14, 2014 be granted (Company requested an extension to March 2014) to assure the company has adequate time to complete all necessary work on Phase I.
