- Move to open the Board of Directors meeting at 8:02 am.

- Suburban Property Maintenance is a company that specializes in the upkeep and maintenance of commercial buildings and grounds. Services they provide include parking lot sweeping, pressure washing, removal of graffiti, painting of light posts, etc. Some of their clients include The Buffalo Bills/Ralph Wilson Stadium, The Benderson Development Company, Home Depot and Walgreens. The company is owned by Marty Ballowe who is looking to purchase 6091 South Park Avenue and use it as his company's headquarters. The building has been vacant for over a year and needs quite a bit of both interior and exterior work. The Board was provided with a list of the work that needed to be done. Marty is requesting assistance in the form of an Adaptive Reuse project. If approved he would be eligible for an exemption from the 1% mortgage tax, the 8.75% NYS sales tax and a property tax abatement equivalent to the 485B. The purpose of the discussion was to determine if the Board felt the project qualified for HIDA assistance. After discussing the project, the Board instructed Executive Director Bartlett to inform the Company they felt the project was potentially eligible for assistance and they would accept an application for review.
- The HIDA has been asked to approve a resolution authorizing the execution and delivery of a gap mortgage, a mortgage consolidation and modification agreement, and an amended and restated Leaseback Agreement, if required, in connection with the refinancing of the 2010 North Forest Properties #5, LLC project. The purpose is to consolidate the outstanding principal balance of the original mortgage and the gap mortgage into a single mortgage in the principal amount of \$715,000.

- The HIDA conducted an Asbestos survey for 70 Lakeview Avenue, which showed Asbestos present in the building and garage in various areas. The Town of Hamburg Code Enforcement Department issued an RFP inviting companies to provide Asbestos abatement services. The following two bids were received:

1. Arric Corporation - \$11,830.00 (if Town supplies electricity) \$16,245.00 (if Arric supplies electricity)

2. Hannah Demolition - \$2,000.00

In addition, we need to pay for someone to monitor the air while the abatement is being done. Kurt Allen recommends Robert Barr at a cost of \$400.00 a day. Kurt was told by Hannah Demolition that he can have the work done in one day. The Board agreed the obvious choice is Hannah Demolition.

- Executive Director Bartlett reviewed a purposed resolution with the Board to extend the PILOT for Keedahm Properties, Inc. by one year. The original project involved the purchase and renovation of an existing 8,400 square foot building located on approximately 3.0 acres at 3780 Hoover Road. The November 2014 storm did substantial damage to the building making it uninhabitable for a considerable period of time with the owner having to replace the building at his own cost. As a result of the damage, the owner did not receive the full benefit of the PILOT and has requested that the Agency agree to extend the term of the PILOT to provide an additional one year of benefits.
