- 2014 Budget- A copy of the proposed 2014 budget was discussed with the Board. The 2014 budget reflects a \$13,907.33 increase over the 2013 budget. The increase reflects a full year of Kevin Kreutzer's consulting contract at \$1,250.00 a month, and the anticipated costs of developing a professional website for the Land Development Corporation. At this point the Board is simply accepting the proposed budget. The budget will then be placed in the Town Clerk's office for thirty days. The actual vote to adopt the 2014 budget will take place on Friday, December 13, 2013.

- The agreement between the Hamburg IDA and Masiello, Martucci, Calabrese and Associates for consulting services is up for renewal. As in the past, Executive Director Bartlett states that he feels strongly that continued membership in the Coalition for Community Building, which is the result of this agreement, is important. The Coalition consists of other IDAs with the same concerns the HIDA has. It not only keeps us informed about issues in Albany that affect Economic Development, but it provides an opportunity to have input on these issues.

-Motion to continue the Hamburg IDA's participation in the Coalition for Community Building for an additional twelve-month period in an amount not to exceed \$500.00 a month and authorizing Executive Director Bartlett to sign a new agreement with Masiello, Martucci, Calabrese and Associates, with the ability of either party to cancel the agreement with a thirty day written notice.

- Executive Director Bartlett asked the Board for approval to attend the New York State Economic Development Council's IDA Section meeting/Economic Development Conference being held on January 22, 2014 and January 23, 2014 in Albany, NY. Expenses would include a hotel (two nights), meals, entertainment, milage and tolls.

-Executive Director Bartlett updated the Board on the 11-8-13 IDA Leadership meeting. The three items discussed at the meeting were:

1. Recapture Policy-Deputy County Executive Rich Tobbe presented a draft Recapture Policy being considered by the ECIDA. Generally, everyone at the meeting recognized that there is merit in defining a process when a project breaches a material term as requested by New York State Law. However, representatives from the five local IDAs felt the proposed ECIDA Policy was too specific and failed to take into account the effect changing economic conditions a company may unexpectedly confront. The next step is to provide feedback on the draft policy to reflect concerns raised by those in attendance.

2. PILOT Schedules- Several people at the meeting expressed concerns about the current PILOT schedules and it was agreed it may be time to review the length and amount of exemptions provided each year. This issue will be revisited at a future date.

3. Senior Housing- A study by the UB Regional Institute shed some light on the limited market country-wide for senior housing. While the study felt, for the most part, the demand for a large senior housing complex of 100 units or more is not there, it did state that the City of Buffalo and The Town of Hamburg were the only municipalities which will see growth in demand to support a 100-plus unit complex. A meeting will be scheduled with developers and the IDA Leadership Council to discuss the need for IDA benefits for these types of projects.

-Sean Ryan has introduced a Bill in the Assembly that he claims will provided necessary oversight to ensure New York taxpayers get their money worth from their substantial investment in Economic Development. Ryan has teamed up with the Coalition for Economic Justice on this bill which Jim Allen refers to as the "Kill all future jobs in NYS Bill." This is a one-house bill at this time.

Website- Mike Sendor, Donna Gavin, Bob Hutchinson, Kevin Kreutzer and Executive Director Bartlett have met and received Website Development Proposals from three companies:

- 1. Trans Webb Marketing
- 2. Keenan Communication Group
- 3. The PCA Group

The next step is to get the group back together to discuss each proposal and come up with a recommendation to the full Board as to which company to hire.

-A discussion took place regarding the Memorandum of Understanding between the Hamburg New York Land Development Corporation and the Krog Corporation calling for collaboration in developing and marketing the Lake Erie Commerce Center. The Board felt the Krog Corporation had not put much effort into promoting the land and some expressed the opinion that the collaboration was hurting us. Executive Director Bartlett explained that we are required to notify Krog in writing sixty days prior to ending the relationship. We will also be responsible for any appropriate costs incurred by Krog Corporation up to this point.

- **Motion** authorizing Executive Director Bartlett to send a letter to the Krog Corporation notifying them that the Hamburg New York Land Development Corporation is terminating our Memorandum of Understanding with them in regards to the Lake Erie Commerce Center.
