- Bob Reynolds and Mary Doran met with Marc O'Hearn from Evans Bank regarding opening CDs in various denominations and lengths to get a better rate of return on savings. Mark stated he did not have a CD with a better rate however he could increase the savings account interest rate from .30 to .65 because the combined balances on all the accounts is over 1 million. He also stated he would increase the rate from .65 to .75 if we transferred \$100,000 to checking. This would increase the yearly return by a little over \$3,000.
